

MEMBERSHIP APPLICATION

GO-WV has two member classifications

GO-WV has two member classifications, Member and Associate.

Member. Any employer that is primarily engaged in the exploration, drilling, production, well servicing, gathering, processing, marketing, transportation, storage or distribution of oil, natural gas and/or NGLs, with operations in West Virginia and those employers that are significantly and directly involved in the West Virginia oil and gas industry and provide services, machinery, supplies and materials directly used or consumed in those activities, shall be eligible to become a "Member" of the Association.

Associate. Any individual or business that is engaged in providing ancillary services or activities related to or supportive of the oil and/or natural gas industry not covered by subsection (a) or who otherwise does not qualify as a Voting Member, shall be eligible to become an "Associate Member" of the Association. Associates shall not have voting rights but shall be entitled to receive all Association membership communications and to participate in all Association meetings and events.

Only those who have significant involvement in the natural gas and oil industry in West Virginia, are employers and are approved for membership by the GO-WV Board of Directors are admitted as Members. Generally, an "employer" employs employees and: (1) has the power to hire and fire; (2) supervises and controls work schedules or conditions of employment; (3) determines the rate and method of payment; and (4) maintains employment records. Generally, an employer withholds taxes and social security payments from salaries or wages, and submits W-2 forms.

Although you may not be significantly tied to the industry or be an employer at this time, we welcome you to join with GO-WV as an Associate. If you check "no" to any of the qualifying questions below, you will be considered for approval as a GO-WV Associate.

Dues categories

Producer/Operator

Those who prospect, develop and produce oil and natural gas. This category includes those who have management responsibilities as either companies or general partners; those who are in charge of the operation; or those who are in the business of producing and operating wells. **Dues**: \$ 0.01 per mcf (most current annual production can be obtained by calling GO-WV at 304.344.9867).

Minimum: \$ 500.00; Maximum: \$ 35,000.00

Storage & Transmission

Companies that transmit or store natural gas. **Dues**: \$ 30,000.00

Local Distribution Company

A company that delivers natural gas via pipeline to natural gas users. **Dues**: \$ 1,000.00 - under 10,000 customers; \$ 10,000.00 - 10,000-100,000 customers;

\$ 20,000.00 - over 100,000 customers

Gathering & Processing

Companies that specialize in the collection of natural gas from various wells then compressing, dehydrating, treating, conditioning and processing it. **Dues**: \$ 20,000.00

Gathering (only)

Companies that collect natural gas from various wells, but do not process it.

Dues: \$ 10,000.00



Those whose primary business is to serve the industry by assisting and participating in the marketing and/or selling of gas and/or oil. **Dues:** \$ 4,000.00



Industry Service Provider

Businesses that are directly involved in oil and natural gas activities. Examples include logging, fracking, cementing, drilling, workover, supplies, wellheads, piping, tubulars, valves, pipeline construction and/or other construction-related activities. Dues are based on the number of WV employees directly related to the oil & gas industry. **Dues**: 1-25 employees - \$ 500.00; 26 or greater employees - \$ 2,000.00

Professional

Those who significantly serve the industry in a professional capacity. Examples may include attorneys, landmen, accountants, surveyors, consulting geologists, engineers, geophysicists and financial advisors. Dues are based on the number of WV employees directly related to the oil and gas industry. **Dues**: 1-25 employees - \$1,000.00; 26 or greater employees - \$2,000.00

Association Affiliate

Those with an interest in the oil and gas industry and do not qualify under any of the other membership categories. **Dues**: \$ 250.00

Friend: Retired

Those retired persons who were employed, at any time previously, by a GO-WV member company or former GO-WV member company and who is not currently or actively employed by a company involved in or associated with the oil and gas industry. **Dues**: \$ 100.00

Friend: Royalty Owner

Those whose only interest in oil and gas production is through the ownership of the royalty, and do not qualify in any of the other membership categories. **Dues**: \$100.00

Friend: Working Interest Owner

Those who own oil and gas wells in West Virginia, or interests therein, and pay some or all of the cost of drilling or operating oil and gas wells. **Dues**: \$ 100.00 – Individuals

Student and/or Teacher

Those interested in the WV oil and gas industry who are currently enrolled in or teach in high school, college or trade school. **Dues**: \$ 25.00
